

# **Kings Worthy Parish Council Accessibility Statement**

Kings Worthy Parish Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations.

We want as many people as possible to be able to use this website. For example, that means you should be able to:

- zoom in up to 300% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver).

## **Compliance status**

The [Web Content Accessibility Guidelines \(WCAG\)](#) defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA. The Council website is conformant with WCAG 2.2 level AAA.

- maps – information maybe available in address format
- third party content under someone else's control
- content on intranets or extranets published before 23 September 2019
- archived websites if not needed for services and they are not updated

## **Assessment Approach**

The Council assessed the accessibility of the website by the following approaches:

- Use of a website provider that automatically updates the website to meet the accessibility guidelines when they change.
- The website is regularly tested on each version release using WCAG2.2AA compliance tools,
