considered, so the Finance committee would like the Planning & Highways committee to review the speed data for the current sites to see if the current sign could be used at the new sites. Finance would also like clarification on why the new sign is being requested.

- <u>Footway resurfacing east side of A33 near B3047 junction</u> Cllr Cossburn noted that he had reported this to HCC. He had been updated and told that the path had been inspected and it was agreed that it does require work. The work will be completed in the next two months with the contractor.
- <u>Proposed closure of Andover road (Kings Barton development)</u> The Deputy Clerk noted that the letter has been sent to HCC and WCC.
