RA/24/192 - Eversley Park exercise equipment - review of quotations

The copy of the exercise equipment quotations has been circulated to Councillors before the meeting.

However, due to the significant extra cost, members were also happy to proceed with Option 1 with rubber mulch at a total cost of £22,790.28.
