P/13/1 Apologies for Absence

Apologies for absence were received from Cllrs Denis Welstead and Stewart Newell.

P/13/2 Public Question Time

There were no items raised.

P/13/3 Minutes of the Meeting held on the 27 November 2012

The minutes were agreed as a true record of the meeting and were signed by Cllr Gordon.

P/13/4 Matters Arising from the Meeting of the 27 November 2012

- P/12/140 Street Lighting the Clerks are continuing to monitor the response times for fault rectification.
- P/12/140 Oakland's, Stoke Charity Road it has been confirmed by Winchester City Council that there have been no breaches of planning legislation at this site.
- P/12/141 Lit Speed Limit Sign it was noted that this has not yet been collected by Micheldever Parish Council.
- P/12/140 Sewerage Issues in North Road area there was no news on the solution for this but there had been no new reported cases since the last meeting.

- P/12/141 Enforcement Notices Winchester City Council's Planning Department have confirmed that the breach had ceased at 70 Fraser Road as the issue was time barred.
- P/12/142 Hinton House tree according to WCC's arboriculturalist the ash tree was causing problems to an adjacent oak tree and therefore it was necessary for it to be felled.
- P/12/144 Kings Worthy Primary School extension Cllr Gordon reported that HCC have been giving good attention to the concerns raised by the Parish Council. The Parish Council is yet to see the detail of the proposal.
- P/12/140 Hookpit Farm Lane it had been reported that a complaint had been made about work starting on site at 06.30. It was noted that there had to be adherence to the times specified in the planning agreement otherwise an offence was committed. It was stated for the record that approval has been given by WCC for 25 dwellings; nothing else has been approved and the Parish Council have not supported anything further.
- P/12/140 Area around Tesco, Springvale Road WCC are currently consulting on double yellow lines. A note has been received from Cllr Newell who is in favour of double yellow lines to include Springvale Road opposite Tesco store, and this was supported by councillors. A letter has been received from Mr & Mrs Evans, of Laburnham Drive, who are objecting to waiting and temporary parking in Hookpit Farm lane as proposed in the consultation. The garages have been tested and declared safe. Cllr Gordon has verbally asked Tesco to mark out the parking places with white paint, but nothing has yet happened. Cllr Gordon is to draft letter that Parish Council don't support the 20 minute parking zone but do support the proposal by Mr. Eade (HCC Highways engineer) to realign the footpath and to replace the grass verge with a lay-by to help ease parking pressures by the corner.
- P/12/140 Reinstatement of land at the junction of B3047/A33 to be carried forward to next meeting re Cllr Gordon contacting HCC regarding this matter. Action – Cllr Gordon

12/02323/FUL	8 Fryers Close SO23 7LP Loft conversion with a rear dormer window (part retrospective) advertising the proposed development is not clear for members of the public to view. The Parish Council would prefer to see it on the cartilage of the property in order that residents can see exactly what is being applied for. A parish councillor was in the area in the last few days and was unaware of any planning application for this property. Furthermore if other properties have only been allowed to use Velux windows then WCC should be enforcing that requirement on this property. Parish Council are concerned that this was allowed to progress to this stage before being picked up as in breach of planning regulations. Therefore Parish Council does not support this application.
