#### P/14/63 Apologies for Absence

#### P/14/65 Minutes of the Meeting held on the 29 April 2014

It was agreed that due to the fact there were several amendments to be recorded, that these be noted and the minutes be altered accordingly following which the chair will review the minutes to ensure that they had been amended accordingly and that they be, agreed and signed, at the next Planning & Highways meeting on 24th June 2014.

#### P/14/66 Matters Arising from the Meeting of the 28 April 2014

P/13/176 Flooding – Cllr White noted that the minutes of the meeting held on flooding, that was chaired by Steve Brine MP, were still not available. Cllr Gordon suggested that the Parish Council needs to move ahead and arrange a meeting with the Environment Agency, Southern Water, Highways organisations and any other appropriate organisations. Cllr White stated that the Parish Council actually need to have two separate meetings, one for the emergency plan and a further meeting as per Cllr Gordon's suggestion. Joanne Higgs, the Solent & South Downs Resilience Team Advisor from the Environment Agency, is to be contacted. **Action – Cllr White.** 

- P/14/34 Planning Application for Woodstock The House in Multiple Occupancy (HMO) is now being taken into consideration for enforcement, now the application has been refused. The landowner has now applied to build two new houses. The previous application must be taken into account when this new application is looked at.
- P/13/176 Redesign of B3047/A33 Junction Highways Agency have gone ahead with their plans without consulting with Hampshire County Council Peter Eade, Highways Manager for HCC, had thanked Cllr Gordon for bringing the early start date of planned works, to his attention. [see table below]

P/14/16 Hyde Home Allocation – The Parish Council have received an email from Debbie Rhodes, Project Manager for Winchester City Council and Strategic Housing Officer for Hampshire Alliance for Rural Affordable Housing (HARAH). It stated that the last two houses were yet to be sold due to the sales falling through. Hyde homes have requested that they now be allowed to move to the 3<sup>rd</sup> level of the S106 agreement cascade. Cllr Gordon emailed Debbie Rhodes asking that the advertising for the remaining properties clearly state where the properties are, rather than advertising them as being at Southside Embankment which is not a suitably recognisable name. The new advertising material, [see copy attached], refers to the site as Hookpit Farm. Cllr Gordon stated that it's taken until this stage for Hyde Homes to advertise the properties proficiently. The London based Head of Sales for Hyde Homes, Sam Welstead, seemed to be put out by having to abide by the S106 agreement.

The Parish Council have been asked by Hyde Homes, if they can move to the 3<sup>rd</sup> tier of the S106 agreement. A member of the public stated that she knew excuses would be made by Hyde Homes, so they could house/sell to anyone

and that this was said in a previous meeting. Another member of the public added that she knows of local people that are willing to purchase the houses on the Hookpit Farm site. Cllr Newell stated that according to the S106 agreement, it states that the council not Hyde Homes are to fulfil the criteria.

Cllr Gordon asked the member of the public to forward the details of any perspective eligible buyers she is aware of, to the Parish Council office. It was also stated that Debbie Rhodes works for both WCC and HARAH, which is a conflict of interest in this case. The responsibility has been passed to Hyde Homes for sales and criteria fulfilment.

Cllr White reiterated the need for a meeting with WCC and Hyde Homes to discuss the S106 agreement. It was agreed that Debbie Rhodes and Emma Combes be included in any meeting to be held to discuss this matter. This meeting is to include Richard Botham, Head of Landlord Services, and Debbie Rhode's boss. Cllr Gordon noted that it's important Winchester City Cllr Robert Johnston be included in the meeting. Cllr Gordon stated that mistakes had also been made in the section of the S106 agreement applying to lettings.

Cllr Gordon noted that no official copy of the S106 agreement had been received nor signed by any Parish Councillor. It was agreed that the Parish council do not agree for them to move to the 3<sup>rd</sup> tier of the S106 agreement. A letter is to be sent to Hyde Homes confirming this. **Action – Clerk & Cllr Gordon.** 

Cllr Gordon is to check that Drew Smith have actually left the site or whether works are still ongoing. **Action – Cllr Gordon** 

**P/14/6 Tesco Site** – Cllr Gordon has not yet been to the site since the refurbishment has taken place. Cllr Gordon has contacted Tesco and raised the issues regarding signage being erected before the application has been decided. Tesco told Cllr Gordon they would look into it but nothing further has been heard. Winchester City council (WCC) are to be contacted to investigate further. **Action** – **Cllr Gordon**. Cllr Gordon is to visit the site and chase a response from Tesco. **Action** – **Cllr Gordon**.

Cllr Welstead stated that the land around the Parish Noticeboard down by Tesco is very dirty. The cut through by Topaz hairdresser is filled with water and in need of repair. Cllr Gordon believes this hedge is the division between the land owned by HCC and that which is owned by Tesco's landlord. Cllrs Gordon and Welstead are to visit these sites to ascertain what further action is needed. **Action- Cllr Gordon and Welstead.** 

HCC are suggesting that the grass verge, adjacent to the car park on Hookpit Farm Lane, could be made into a layby but funding is a problem. Cllr Gordon

stated that the Parish Council needs to put more pressure on HCC to get this done.

Now the road repairs and Tesco refurbishment are complete the Lorries have been returning to their early deliveries. A member of the public stated that she had been informed by Tesco that the deliveries to that store take place at 08:00. Cllr Gordon noted that a member of the public had informed the Parish Council that there is a restriction on delivery times at the store.

A notice has now gone up, restricting parking to 20 minutes. The proprietor of Topaz hairdressers has contacted the Parish Council office and stated that the car park is shared and their customers need more than 20 minutes. Cllr Gordon is to check who erected the notice. **Action – Cllr Gordon.**

#### What is this consultation about?

Hampshire County Council needs to save £1.25-£1.5 million from public and community transport spending by 2015/16 and this consultation form aims to collect the views and preferences of groups and organisations to aid us in the decision making process. A separate consultation form can be completed to collect the views and preferences of individual users.

What does Hampshire County Council currently spend and provide?

Currently Hampshire County Council spends £4.7 million on supporting local bus service and ferries across Hampshire, with a further £1 million spent on supporting community transport services. The County Council supports 200 bus services across the county, which accounts for 28% of bus journeys, the other 72% being made on commercial services which do not receive a subsidy from the County Council. The bus services supported by the County Council cater for around 4 million of the 30 million bus passenger trips in Hampshire in a year. In addition to this Hampshire County Council spends £13.4 million on concessionary fares providing people with older, disabled and companion passes and travel vouchers.

#### How can I take part in this consultation?
