Cllr Gordon reported that he had, on 24 April, received a petition from residents of Willis Waye and The Dell concerned about the speed of traffic using Willis Waye; this petition has been copied to HCC. The residents are petitioning for a 20 mph speed limit and Children at Play signs and are seeking Parish Council support. Additionally they are keen to see deeper parking lay bys to allow nose in parking and dragons teeth erected to prevent parking on the green.
