P/13/96 Apologies for Absence

Cllr Denis Welstead had sent his apologies for absence.

P/13/97 Public Question Time

No questions were received.

P/13/98 Minutes of the Meeting held on the 28 May 2013

The minutes were agreed as a true record of the meeting and were signed by Cllr Gordon.

P/13/99 Matters Arising from the Meeting of the 28 May 2013

• P/13/84 Tesco site – Cllr Gordon has spoken with Winchester City Council's (WCC) Enforcement Officer, who has said that the site owner has ignored 4 letters from WCC. In the next couple of months WCC will be serving notice for the garages to be demolished or repaired placing a charge on the property if necessary. The owner would have a right of appeal against the notice to a magistrate's court. This notice will be served on the tenants as well as there is a perceived lack of clarity in the leases.

Environmental Protection are aware of the issues re the unitainers on site but have commented that Tesco are complying with food hygiene regulations.

Tesco are still hoping to persuade the landlord to permit them to paint white lines in the car park, and to allow them to extend their storage area to take away the unitainers currently stored outside their compound.

- P/13/85 PFI Street Lighting Contract a meeting is scheduled for July 4th to progress this matter further. It was noted that the PFI agreement was signed in 2009. The lighting on some streets is not up to HCC standards for adoption, in some cases because of distance between the overhead power lines and the posts on which the lighting units are attached. If lights were brought up to standard there would be a risk of complaints from residents regarding light pollution and disturbance. The current plan is for a few more lights along Springvale Road to fill some of the gaps, and this should not cost much more on an annual running cost basis as the total would be kept within the existing budget.
- P/13/86 Discussion on HCC's proposals for redesign of B3047 / A33 and Lovedon Lane / A33 junctions Steve Brine, as the local MP, has called a meeting for the 1st July to discuss the safety issues around these junctions. He has invited officers from HCC, the leader of WCC, local and county councillors, the police, parish councillors and UIVS. Members considered that the current budget offer was derisory, particularly as S106 monies have been collected for several years towards work on this junction.

Cllr Gordon reported that the tin shed on the grass at this junction was in the process of being demolished.

P/13/100 To discuss issues from the Parish Council Meeting – Springvale Road Speed Limit

This item was brought forward on the agenda at the request of the members of the public present. It was noted that the Parish Council is going ahead with a survey which is being sent to all the residents of Kings Worthy. This will be a standalone document, with nothing else attached, containing a straightforward question. The exact wording is being agreed with HCC staff to double check that it meets requirements.

P/13/101 Mountbatten Place garages

The site of the garages in Mountbatten Place have been identified by WCC as a possible site for housing development. Councillors agreed that this would be a better use of the land than at present.

It was also suggested that the hedge around the public car park at the back of Tubbs Hall be removed to make it a more attractive proposition for local residents to use.
