P/13/36 Apologies for Absence

P/13/37 Public Question Time

P/13/38 Minutes of the Meeting held on the 29 January 2013

P/13/39 Matters Arising from the Meeting of the 29 January 2013

P/13/22 Hookpit Farm Lane / area around Tesco site - Cllr Gordon, together with Kings Worthy's County and City Councillors, will write to Tesco to see if it is possible to get the car park properly marked out and to request that the "unitainer" site is kept tidy. Drew Smith have indicated that they would be willing to put in a lay-by on the verge outside Tesco.

- P/13/22 Reinstatement of land at the junction of B3047/A33 Cllr Taylor was attending the meeting of the South Downs National Park Authority today and will be raising this issue at the meeting. Cllr Gordon had emailed Peter Eade (HCC) about the highways material in the tin hut on the site. Action Cllr Taylor
- P13/22 Kings Worthy Primary School extension HCC, as the Education Authority, has granted permission for this work as no objections had been received. This project now needs to be taken forward for planning permission.
- P/13/24 Planning Applications for Trees it was reported that applications for tree works were being copied to the parish office, despite Cllr Gordon being told by the arboriculturalist that this notification was to cease.
- P/13/26 Speed bumps and Speed Limits it was suggested that Cllr Steventon-Baker raise a public petition about the traffic speeding out of The Heights, and that this petition should be sent to HCC and WCC. Action – Cllr Steventon-Baker
 - Cllr Allen suggested contacting Peter Watson (HCC Countryside Service) about the material being deposited on the highway without permission as this was potentially a criminal offence. In addition it would be helpful for some of the tarmac to be coloured differently to encourage drivers to give way. **Action Cllr Gordon**
- P/13/28 Illegal Advertising Signs it was noted that the incidence of this had reduced recently.
