P/13/49 Apologies for Absence

Cllr Phil Allen had sent apologies for his late arrival for the meeting.

P/13/50 Public Question Time

There were no members of the public present.

P/13/51 Minutes of the Meeting held on the 26 February 2013

The minutes were agreed as a true record of the meeting and were signed by Cllr Gordon.

P/13/52 Matters Arising from the Meeting of the 26 February 2013

- P/13/39 Hookpit Farm Lane / area around Tesco site Cllr Gordon had spoken with someone from Tesco's legal department who had made contact with the Parish Council as a result of the number of emails that Tesco had received from local residents. Following this Parish Council were sent Land Registry information to showing the land that Tesco rent and that Tesco wish to rent a larger area for the "unitainers".
- P/13/39 Reinstatement of land at the junction of B3047/A33 -Cllr Gordon had emailed Peter Eade (HCC) has agreed to remove the tin hut from the site. Cllr Taylor had raised the issue of signposting the entrance to the park but South Downs National Park Authority are responsible for 100s of entrances to the park and are therefore unlikely to be taking any action in the near future.

P/13/39 Speed bumps and Speed Limits – Cllr Gordon had received a letter from a resident of Churchill Close and he undertook to request that HCC and WCC for the colouring of the footway, signage and possibly bumps. **Action – Cllr Gordon**

Cllr Steventon-Baker had challenged the refuse collectors about their lorries reversing out of Churchill Close and it was noted that, this week, the vehicles had turned and driven out forwards; this to be monitored with dates and details.

Nothing had been heard back from Cllr Porter yet about the Springvale road traffic survey. Cllr Gordon will speak to Peter Eade (HCC). **Action – Cllr Gordon**

P/13/39 Terms of Reference – after discussion the following was agreed:

Membership

- The Planning and Highways Committee will comprise at least five (5) members chosen by the full Parish Council from its Councillors.
- The Chair of the Committee and the Vice-Chair will be decided by the committee members and elected annually.

Quorum

o A quorum will be three (3) Councillors; non-members may be invited to attend Planning & Highways Committee meetings, but will not be able to vote.

Terms of Reference

 Terms of reference describe the purpose and structure of a project, committee, meeting, negotiation, or any similar collection of people who have agreed to work together to accomplish a shared goal.

For the Kings Worthy Parish Council Planning and Highways Committee the terms of reference are to consider and make recommendations on:

- Planning and associated items, including applications submitted to both Winchester City Council and South Downs National Park Authority
- Highways and associated infrastructure, but excluding footpaths not adjacent to public highways
- Policing, crime prevention and public protection
- Traffic issues

Neil Holmes (Quayside Architects Ltd) had sent a new map on 15th March but this had not shown the full area under consideration. Cllr Allen suggested that Parish Council write showing what was agreed in principle and that the red route was acceptable as a grass trail. Cllr Allen had drafted a letter to go to HCC, on headed paper, which was a record of the dialogue to date. It was agreed to recommend the proposals to full Parish Council. Action the Clerk
