P/12/31 Apologies for Absence

There were no apologies for absence. Cllr Kirstie Andrew-Power did not attend.

P/12/32 Public Question Time

Mr Chris Rees, from Savills, made a pre-planning application presentation on proposals for a site at Mount pleasant. Initially a modern approach had been taken with a shingle and render finish and a flat roof. Initial feedback was that "modern" was not popular so Savills' architect has now produced a more traditional proposal with a traditional brick finish. There was no objection to having two traditionally finished properties at the front with three more modern ones at the back which were not visible from the road and which would blend into the side of the hill giving a more acceptable view of the hillside.

P/12/33 Minutes of the Meeting held on the 28 February 2012

The minutes were agreed as a true record of the meeting and were signed by Cllr Gordon.

P/12/34 Matters Arising from the Meeting of the 28 February 2012

O P/12/19 Power Supply – Cllr Gordon reported that there had been only one minor cut recently. Steve Brine wants to delay the meeting, to be held on a Friday, until after the May local government elections. Cllr Gordon has written to Steve Brine to say that this was not a political issue so that there was no reason to delay. Cllr Gordon also suggested that the meeting could be held after a Parish Council meeting on a Monday to maximise public access.

- P/12/19 Street Lighting in Abbots Worthy Cllr Gordon has spoken to the complainant and suggested waiting until after the current round of street lighting upgrades in the area.
- P/12/19 Local Bus Services it was viewed that not having an evening bus service was an attempt to maximise revenue from car parking charges. Money spent on evening traffic wardens would be better spent on subsidising bus services. Further investigation is required. Action – Clir Barnes
- P/12/19 Trees on Kim Bishop Walk trees on land that the Parish Council own are a matter for the R&A committee. Cllr Gordon made reference to Kelvin Mason's report. Ownership of the fencing alongside the path is being investigated. Action – the clerk
- P/12/19 Lit Speed Limit Sign recorded nearly 4000 vehicles over the limit in London Road and 2500 in Church Lane, in a week each.
- P/12/27 Dashboard The Deputy Clerk explained the content of the dashboard report. The spend on street lighting was £6248 against a budget of £8000. Concern was raised about the length of time taken to fix reported faults and the Clerk is to write to the highways authority to raise this. Action – The Clerk
