## P/12/60 Apologies for Absence

### P/12/62 Public Question Time

There were no members of the public in attendance.

### P/12/63 Minutes of the Meeting held on the 24 April 2012

The minutes were agreed as a true record of the meeting and were signed by Cllr Gordon.

### P/12/64 Matters Arising from the Meeting of the 24 April 2012

 P/12/49 Trees on Kim Bishop Walk – quotes for the work are being obtained by the Recreation & Amenities Committee.

- P/12/49 Street Lighting it may not be possible to relocate the street light, which is shining into a house in Abbots Worthy, because of the entry to Abbots Worthy House. A letter has been sent to HCC complaining about the time taken to fix notified faults; a response is awaited.
- P/12/50 Red Marley this planning application is still under consideration by WCC.
- P/12/52 Land at Lovedon Lane Cllr Gordon to action draft reply to Turley Associates, for parish Council to send.
- P/12/53 Parking the PCSO will put a letter, drafted by Parish Council, on vehicles parked on grass verges causing damage to grass verges and kerbing. Cllr Steventon Baker will investigate if English Landscapes are unable to mow grass because of vehicular obstructions. Action – Cllr Steventon Baker
- P/12/54 Tesco Garages nothing to report.
- P/12/58 Asbestos Bags these were removed after notice was placed on them by a "concerned neighbour". Cllr Gordon is to write to the Health & safety Executive to ask how contact can be made with them in an emergency. Action – Cllr Gordon
- P/12/47 Willis Waye Traffic a petition had been raised by the Willis Waye residents concerned about the speed of traffic. A reply had been received from Cllr Thornber (HCC) and the issue had been reported to the Police.
- P/12/56 Churchill Close all but one of the houses now complete. A letter needed to be sent to Robert Heathcoat (WCC) stating that, as the development was now complete, could he make arrangements for BIFFA to drive in and out forwards and that bins are no longer to be taken to the end of the development for collection. A memo to be sent to Cllr Porter re cracks and damage to the road surface and drains to get HCC to repair. Action The Clerk

**Hookpit Farm Lane** – it was noted that some of the development could be outside the boundary of the settlement. It was agreed that Parish Council could have a caveat that the properties should be sold with shared ownership for Kings Worthy residents or people with Kings Worthy connections.

The developers want to hold a further meeting with Councillors but it was agreed that, at present, this should not be held outside P&H meetings where councillors could give an opinion to be passed to the full Parish Council were applicable.

A memory stick is to be provided for each member of the committee to facilitate the distribution of large sized planning files **Action – The Clerk** 

### P/12/78 Chairman's Notices

It was reported that agreement had been reached for the breakdown vehicle to be parked in a farm entrance in Lovedon lane; the agreement to cease if the farmer has any problems with this from any source. Cllr Gordon will speak to the landowner. **Action – Cllr Gordon** 

A caravan has been parked in Harewood Place causing complaints. HCC and WCC keep passing the issue between them. Cllr Gordon will investigate. **Action** – **Cllr Gordon** 

It was reported that Scottish and southern Energy have agreed to reinstate the ground on the triangle between the B3047 and the A33.
