P/12/1 Apologies for Absence

Apologies for absence had been received from Cllr Denis Welstead.

P/12/2 Public Question Time

Mr Salter made a pre-planning application presentation on his proposals at the Path of Thyme, Legion lane, Kings Worthy. Mr Salter, on behalf of his company The Home Shop, showed the existing floor plan and proposals for a bigger kitchen and one further bedroom. The proposals would turn the existing single storey bungalow into a chalet by building out 2m at front and building up to the existing roof slope. The existing detached garage would be demolished and replaced by a new attached garage on the side. A covered porch would be added in front of a relocated front door. Additional dormer window would give secondary means of escape and 2 bedrooms upstairs.

P/12/3 Minutes of the Meeting held on the 29 October 2011

P/12/4 Matters Arising from the Meeting of the 29 November 2011

P/11/118 Electricity Supply - Power Cuts - Cllr Gordon reported a
major power cut in week ended 28 January, caused by excavation works
for new sub-station. Cllr Gordon telephoned, following the electricity
company's complaints procedure, and as a result letters were distributed,
by Scottish & Southern Electricity, to residents giving an explanation as to
what had happened.

P/12/4 Matters Arising from the Meeting of the 29 November 2011 cont.

- P/11/118 Dog Fouling the meeting, originally scheduled for 14 December 2011, between the dog warden, Cllr White, Cllr Read and the Clerk took place on 25 January. It was understood that the meeting was productive.
- P/11/118 Ramsey Road Development this was raised again at Parish Council meeting on 16 January. Cllr Gordon will speak to Cllr Welstead and further contact will be made with the Health & Safety Executive if the appropriate legislation suggests such a course of action. It was believed that the disagreement between the site owner and the builder was now resolved.
- P/11/121 Highways Issues Churchill Close Cllr Gordon reported that it
 was unlikely that the Parish Council would be able to have the matter
 reviewed until the builder was off site, when a proper appraisal of the
 situation could take place. It is thought that the builder should be off site
 by the end of March.
- P/11/123 Budget 2012-13 Cllr Gordon wants to make sure that the lit speed limit sign is not "lost" in the overall projects heading within the 2012-13 budget where other projects could take precedence.

Kim Bishop Walk – the Deputy Clerk summarised the advice given by a parishioner, who was qualified in the field of ecology and arborital management, and had been asked to advise on the matter. The recommendation was to not sell any parts of the land on a piecemeal basis without having a detailed plan for the whole site. It was recommended that the walnut tree, which is situated on the bank at the rear of the Path of Thyme, be felled. The comments received from local residents were noted. The land, footpath and banking, was entrusted to the Parish Council for safekeeping on behalf of members of the public. As a result it was decided that it was not for the Parish Council to sell off any parts thereof piecemeal. This needs to go to Parish Council for approval.

The Clerks were requested to obtain 3 quotes for remedial work on the walnut tree, to be put to Finance Committee on 15 February.
