Minutes of the Planning & Highways committee meeting held on Tuesday, 17 August 2021 at 19:30 in Kings Worthy Community Centre, Fraser Road, Kings Worthy

P/21/050 – Election of Chair

Cllr Gordon was proposed by Cllr Haswell and seconded by Cllr Hallisey. Cllr Gordon was unanimously elected as Chair.

P/21/051 – Election of Vice-Chair

Cllr Cossburn was proposed by Cllr Hallisey and seconded by Cllr Haswell. Cllr Cossburn was unanimously elected as Vice-Chair.

P/21/052 – Public question time

Two members of public in attendance raised the current issues with speeding on the B3047, particularly around the junction with Mill Lane. There was a recent accident with a vehicle going through a properties hedge and hitting their extension causing it to move.

They requested that the Parish Council's speed sign be deployed near the junction.

They had produced a dossier on the issue and requested the Parish Council's support on this issue including a potential reduction in the speed limit. A copy of this dossier will be shared with the Parish Council.

Cllr Gordon stated a site in Abbots Worthy is already being proposed for agreement under the next agenda item. He also advised residents to keep a personal log of accidents to help provide data.

Cllr Cramoysan (WCC) stated that he fully supported the residents on the issues in Abbots Worthy. He also listed the sites that had been raised as potential speeding hotspots which are:

- Lovedon Lane (between Broadview Close & A33)
- Springvale Road (past Bentley Close from A34 bridge to Nations Hill). Partly within Kings Worthy Parish
- Church Lane (from Cornerways to bottom of the hill)
- Fraser Road (from Forbes Road to the shops)
- A33 (south) approaching the Lovedon Lane junction

CLlr Gordon stated that the A33 is a major road thus we cannot deploy our speed sign at that location. It was also stated that Church Lane has been discussed many times but finding a suitable site is difficult, particularly with the width of the road. The issue of Heavy Good Vehicles (HGVs) has also been raised with Hampshire County Council (HCC), but they are only willing to put up blue signs to try and prevent HGVs.

WCC produced a plan to install yellow lines along Fraser Road 2-3 years ago. This has not happened and would also need the yellow lines to be enforced.

CLlr Cossburn noted that speed sign is currently being deployed at a site in Springvale Road. It is also deployed on Nations Hill/Church Lane by the school. He noted the average speed for that site was approximately 25-26 mph.

P/21/053 – Speeding within the village

CLlr Cossburn gave a presentation for 4 new proposed sites for the deployment of the speed sign.

- Lovedon Lane (near the turning to Loader Close)
- Springvale Road (adjacent to Elan Court) – Will need a new post fitted which will need to be agreed with the management company for Elan Court.
- B3047 [Abbots Worthy] (near the Mill Lane junction) – This site will need a replacement post of significant height which is intended to be funded by the Parish Council.
- Stoke Charity Road (near the turning to Cloverbank)

Action: It was unanimously agreed to proceed with obtaining the necessary permissions for the site listed above.

CLlr Cossburn stated that the addition of the four extra sites would be the maximum that the existing sign could cope with and any additional sites would require release of funding to purchase a second device.

CLlr Cossburn noted that Phase 2 would be:

- To canvas parishioners for suggestions on potential traffic calming measures
- Meet with HCC highways officer to discuss proposal with them.
- Report speed finding on the Parish Council website and in the Parish Magazine.

T1 Lime. Crown lift to 4m G1 3 No Ash trees. Fell to ground level - Ash dieback disease.

14 Bentley Close Kings Worthy SO23 7LG

Scots Pine tree - Fell. (see original application)

Response/Action –

Chinese Privet (T1) - Fell. In decline, poor vigour. To be replaced- customer not sure of species, have suggested Beech.

89A Springvale Road Kings Worthy Winchester Hampshire SO23 7RB

Yew tree - branches overhanging garden crown raise to a height of 4m, in effect removing the branches back to the trunk to a height double that of the existing fence. (See original application)

Response/Action -

The Parish Council wish to defer this decision to the arboricultural officer.

P/21/057 - Available Updates (if any)

- Ecogen application - The Hampshire Chronicle had run a story stating that this application will be re-consulted. The Clerk had written to HCC to ascertain the timescales including when revised information will be received but no reply had yet been received.
- Winchester City Council Top Field development - The building work is finished but the footpaths are starting to become overgrown.
Action - Chase Winchester City Council for information on when the footpaths and open space will be finished.
- Land adjacent to Tudor Way - Nothing further.

- Contractor parking within the village – This is being dealt with by one of our City Councillors for the area.

P/21/058 – Planning & Highways dashboard; includes planning decisions advised since the last meeting and enforcement notices

Members reviewed the dashboard including decisions issued by the relevant planning authorities (information is publicly available from relevant authority).

Action – It was agreed for Cllr Gordon to contact WCC planning enforcement about the Rod Box works now that the appeal has been dismissed.
