#### **RA/12/01 Apologies for Absence**

None

#### **RA/12/02 Public Question Time**

None

#### **RA/12/03 Minutes of the Meeting held on the 3 November 2011**

The minutes were agreed as a true record of the meeting and were signed by Cllr White.

#### **RA/12/04 Matters Arising from the Meeting of the 3 November 2011**

- **RA/11/124 – Exercise Sessions** – the clerk confirmed that the last of the three pilot sessions will be held on the 27 January 2012. The trainer had highlighted the poor state of the grass in the area. Members agreed to review this in the summer.
- **RA/11/109 – Notice Boards** – the clerk was asked to chase Amey for the repair of the cracked section on the replacement board outside of the King Charles PH. **Action – the clerk**

## **RA/12/04 Matters Arising from the Meeting of the 3 November 2011 cont.**

- **RA/11/125 - Fraser Road Children's Playground** – Cllrs Hallisey and Sign highlighted the recent incidents of vandalism. Members agreed that this and other recent incidents should be discussed with PC Don Hagger. If he is unable to attend the next PC meeting, the clerk was asked to arrange a special meeting. **Action – the clerk**

Cllr White confirmed that the meeting with the young people in the area had been arranged for the 25 January 2012 at 7.30pm in the Tubbs Hall. Members agreed that hot chocolate and squash should be served. It is hoped that as many councillors as possible would attend. Ideas for discussion should be sent to Cllr White. **Action – All Councillors**

- **A/11/126 - Dog Fouling** – Cllr Sign highlighted again the problem on Springvale Road. Cllr White informed members that the meeting with the WCC Dog Warden had been re-arranged for the 25 January 2012. The option of spraying deposits with a bright colour would be discussed.

## **RA/12/05 Burial Ground**

Members noted the Registrar's quarterly report.

## **RA/12/06 Project Updates**

The Project Status Report had been circulated to members [copy attached].

- **Eversley Park - MUGA** – this could now be deleted from the listing as the project had been completed.
- **Fraser Road - Children's Playground** – Members noted that the paint snagging is to be completed within the next few days.
- **Eversley Park – Changing Room/Toilet Facilities** – the clerk was asked to request an update from WSCC on the progress of the improvements in February. **Action – the clerk**
- **Eversley Park - Swing Seat for Disabled Children** – this had been returned to the supplier as being unsuitable for a public recreation area. Alternative suppliers are being sought. **Action – the clerk**
- **Eversley Park – Cricket Nets** – a project group had been formed consisting of Cllrs Andrew-Power, Bohle and Prince. Cllr Bohle had been in discussion with Angus McQueen who is the lead person for cricket within the village. Funding will hopefully come from S106 monies with a possible contribution from Headbourne Worthy PC.

## **RA/12/07      General Maintenance/Equipment Repairs**

A listing of general maintenance and equipment repairs had been circulated to members [copy attached]

- **Eversley Park – Path Resurfacing** – Cllr White had been invited to a meeting to review the school travel plan. Members deferred a decision to consider the recommendations from this meeting.
- **Eversley Park - Children’s Playground** – Members agreed that the repairs recommended in the ROSP Report should be presented to PC for approval. The clerk was asked to query the charge for carriage for the new parts from RSS. **Action – the clerk**

The work on the entrances should be presented to the Finance Committee for approval. The clerk will confirm again with the contractor that the slabs and base are of industrial grade. **Action – the clerk**

- **Church Green - Tree Works** – Members expressed their concerns that this work was still outstanding. The clerk was asked to give notice to the contractor that the work be completed by the end of January. **Action – the clerk**
- **Fraser Road - Exercise Equipment** – Members agreed that the repairs to the skier should be presented to the Finance Committee for approval. Cllr Bohle suggested that a stake may stabilise the Surfer. The clerk was asked to investigate. **Action – the clerk**
- **Burial Ground – Root Barrier** – Members agreed that an interim measure of cutting the root should be undertaken by Scandor. **Action – the clerk**
- **Upper Broadview** – Members asked the clerk to chase WCC for the completion of this work as part of the S106 Agreement. **Action – the clerk**

## **RA/12/08      Bus Shelters**

Members were delighted with the improvements undertaken by Queensbury. Cllr Bohle and the clerk are to arrange to inspect each shelter with the supplier to ensure that the work undertaken was as specified. **Action – Cllr Bohle/clerk**

## **RA/12/09      Website**

Cllr White indicated that there was no further progress to report.

## **RA/12/10      Budget 2012-13**

Members had no further comment on the draft budget for 2012-13.

Cllr White indicated that there may be a small additional cost in publishing an Annual Report as part of the status for a Quality Council.

## **RA/12/11 Burial Ground Regulations**

Discussion took place on the revisions required to update these regulations.

Members agreed that a minor amendment should be made to para' 13, to include headstones and crosses. Cllr White agreed to circulate an advice note from HALC on burial fees for members to consider.

The clerk was asked to contact a local funeral director for their advice on the issuing of the regulations to relatives of the deceased. **Action – the clerk**

Members agreed to the request from Mrs March to remove her mother's ashes to Wales. **Action – the clerk**

## **RA/12/12 Clerk's Notices**

- **Christmas Lights** – An appeal had been received from a parishioner for Christmas lights in the village. Members indicated that this was a matter for each individual household. He also suggested that there should be a Christmas get-together for the village. Members asked the clerk to respond that the "Mystery of Christmas" which is held each year, is a jointly sponsored event between the Church, PC and THMC.
