The new Worthys Youth Football Club (WYFC) Co-Chair and Club Secretary gave a presentation to Councillors on their vision for the club. Their main aims are:

- To have basic facilities such as toilets at all their hired facilities.
- To have enough pitches to run 2 teams per age group simultaneously.
- To have a storage facility at every site.
- To get a club newsletter up and running to incorporate parking etc. among other club news.

They are currently the largest team in the Testway league.
