A member of the public expressed their concerns about the speed limit on Lovedon Lane.

They also asked:

- Why is the speed sign gone after certain days from Lovedon Lane? – Cllr Cossburn noted our speed sign goes up on Tuesday at a different site, is turned around to face the other direction the following Tuesday, and gets taken down the following week to move to a different site.
- Why do we have 2 speed cameras on Springvale Road? - Cllr Cossburn noted that one of the cameras belongs to Headbourne Worthy Parish Council.

The Parish Council is investigating a second speed sign with automatic number plate recognition (ANPR).

*SINGLE AND TWO STOREY EXTENSIONS AND ASSOCIATED ALTERATIONS TO DWELLING TO INCLUDE A NEW GARDEN STORE AND VEHICULAR / PEDESTRIAN ACCESS*

The size of the proposed extensions are too large in relation to the existing dwelling and site. There is also concern about the potential loss of local amenities and the suitability of the proposed access, particularly given the proximity of neighbouring accesses.
