Erection of an ancillary outbuilding, carport, driveway and access alterations

Response/Action: The Council objects to this application due to the excessive scale and footprint of the proposed annexe, which significantly exceeds the size of the building it would replace. There are also concerns regarding the potential future use of the building as an independent holiday let.

It was agreed to seek advice from Winchester City Council (WCC) on whether planning permission would be required.

P/26/072 – M3 Junction 9 works and closures

Cllr Cossburn noted that the M3 northbound slip road from Winnall would be closed from 31 July 2026 until winter 2027. There would also be some weekend closures of the A33, A34, M3 Junction 9 southbound slip road and the A272 Spitfire Link, commencing from 31 July 2026.

P/26/073 – Parking on the verges in Fraser Road including potential solutions

Following a discussion, potential solutions were put forward;

- To remove some grass verges and convert to parking bays, although it was noted that Hampshire County Council own the grass verges and not the Parish Council.
- The use of parking permits may encourage people to park in their garages rather than on the road.

It was agreed that any parking solutions should include electric charging points and disabled spaces where possible.
