A member of the public spoke about Bee Orchids growing on the football pitch at Church Green and asked about the possibility of moving them to a better location within the grounds of St. Marys Church.

RA/26/054 – Lovedon Fields site

- **Grant for an interpretation board explaining the biodiversity of the meadow** – The deadline for the Grant has unfortunately been missed.
- **Allotments update including update on water supply** – The water pipe has been located ready for the meter to be fitted. The rotavating of the plots has

been completed along with the installation of compost bins and boot scraper. The metal tool lockers have now been delivered and are awaiting installation. There are still 2 vacant plots.

- **Parish Council tree inspection updates (including trees adjacent to Eversley Park play area & Legion Lane) including quotations for recommended works** – no update

- **Update on resurfacing footpath between Hinton Fields and Church Lane** – The Deputy Clerk gave an update, and it was agreed to purchase new pedestrian barriers - the cost of these to be included in the quotation.
- **Review of planted areas adjacent to new cremation area** – Girl Guides to plant bulbs and tidy paths of twigs.

- **Replacement notice board for Lovedon Lane Burial Ground** – Quotations have been received and were reviewed by members.
