### **RA/26/039 - Lovedon Fields site**

- **Grant for an Interpretation board explaining the biodiversity of the meadow** – It was agreed to defer this item to the next meeting.
- **Allotments update including update on water supply (including quotations for locating water pipe and installation of boot scraper)** – It was agreed to proceed with a quotation from M.R.S. Services at a total cost of £207.00.

### **RA/26/040 – Tree works/general maintenance**

- **Parish Council tree inspection updates (including trees adjacent to Eversley Park play area & Legion Lane) including quotations for recommended works** – Awaiting advice from our tree consultant.
- **Update on Fryers Close play area including potential consultation** – A consultation letter has been distributed to surrounding residents.
- **Actions from play area annual inspections** – Due to the absence of the Deputy Clerk, it was agreed to defer this item to the next meeting.
- **Remedial works at Fraser Road play area** – It was unanimously agreed that the final payment can be made subject to confirmation that the outstanding work has been completed.
- **Update on resurfacing footpath between Hinton Fields and Church Lane (including potential resurfacing)** – The proposed specification for path was agreed and the Clerks will obtain quotations.  
**Action – Clerks to obtain quotations for the path works.**
- **Review of planted areas adjacent to new cremation area** – A tree crown lift may be required. Members to look at a planting plan to bring to next meeting.

### **RA/26/041 – To review the 2025/26 forecast outturn and 2026/27 final budget**

- Fencing and steps at the bottom of Lower Broadview
- Planting and works to water feature at the Burial Ground
- Minor crown lift of trees at the Burial Ground
